## SWIMMING POOL REGULATIONS

### ACCESS TO THE SWIMMING POOL

- Visitors are requested to shower before entering the swimming pool.
- Appropriate swimwear must be worn to enter the swimming pool. Hof van Saksen is a family resort. In case of a difference of opinion, Management will decide.
- Children younger than 8 may only have access to the swimming pool under the supervision of an adult.
- Children, who do not have sufficiently well developed swimming skills, must use flotation devices and must be supervised by an adult, who is a competent swimmer (Stage 5).
- All children, who are not yet toilet-trained, must wear a swimming nappy.
- Children with a swimming certificate may swim without flotation devices.

### STAY IN THE SWIMMING POOL

- Visitors must behave in such a way that good order, safety and hygiene are maintained.
- Running is not allowed.
- Diving is not allowed, except from the starting blocks in the competition pool.
- Smoking in the swimming pool is not allowed, nor is it allowed outside in the wild water rapids.
- The use of soap and shampoo is not allowed in the swimming pool, with the exception of the shower areas.
- The wild water rapids and water slides may only be accessed when the water flow is operational.
- Standing, walking and carrying objects in the wild water rapids and water slides is absolutely not allowed.
- In the event of bad weather visitors must leave the wild water rapids and water slides.
- Wear and tear to swimwear may occur as a result of repeated use of the wild water rapids and water slides.
- Service and staff rooms may only be accessed by staff.
- When it is very busy in the swimming pool the number of visitors may be limited in order to maintain safety. Hof van Saksen reserves the right to change the opening times of the swimming pool and to fully or partially close the complex.

It is not permitted to take or use the following items into the swimming pool:

- Any kind of glass product, thermos flasks, picnic and cool-boxes, food or beverages.
- Bags, with the exception of nappy bags.
- Play equipment, such as air beds and tennis balls.
- Audio, photographic and video equipment with a cable connection. Photographic and video equipment may never be used in the swimming pool changing and shower rooms.
- Objects, which might cause physical injury to visitors, such as knives, syringes and drugs.

### LOCKERS

Visitors must store their clothing and other belongings in the lockers provided for this purpose in the changing rooms. Do not bring any valuables with you. Items cannot be handed in for safekeeping. Visitors must empty the locker that has been used upon exiting the swimming pool. The staff are authorised to take clothing out of the changing rooms and to empty the lockers after closing time.

### REFUSAL OF ACCESS TO OR REMOVAL FROM THE SWIMMING POOL

Access to the swimming pool will be denied and/or one's stay will be terminated in case of the following violations:

- Disrupting peace and order.
- Failing to follow the instructions of staff or failing to observe the regulations.
- Being under the influence of alcohol or drugs.
- Suffering from contagious illnesses or having open wounds.
- Committing theft. In case of theft, this will always be reported to the police.
- In the event of repeated violations, access can be denied for an (in)definite period of time without any refund of entrance fees.

### LIABILITY

A visit to the swimming pool is at your own risk. Hof van Saksen shall not be held liable for accidents, theft or damage to property belonging to visitors to the swimming pool. Visitors, who cause damage to the property of Hof van Saksen shall be held liable for all costs arising out of repairs and/or replacement.
